EUROPEAN WEEE RESPONSIBILITIES FOR DIRECT SALES

Directive 2002/96/EC of the European Union on waste electrical and electronic equipment (WEEE) mandates certain responsibilities for producers and users of electronic equipment for financing the recycling of electronic equipment. Since Avtech does not have any local subsidiaries within the European Union, responsibility for the WEEE-related obligations will be transferred to the customer, as provided for in Article 9 of Directive 2002/96/EC.

This only applies to direct purchases by European customers from Avtech Electrosystems in North America.

Customers who are unable or unwilling to meet these requirements should instead order from the nearest Avtech representative within the European Union. Schulz-Electronic GmbH in Austria, Germany, and Switzerland (www.schulz-electronic.de) will be happy to assist you. Unless otherwise arranged, the responsibility for WEEE compliance will lie with the local representative, rather than the customer.

ROHS COMPLIANCE

Avtech instruments are considered "Monitoring and control instruments" (Category 9) as defined in Annex 1A of Directive 2002/96/EC on waste electrical and electronic equipment (WEEE). The RoHS directive (Directive 2002/95/EC) only applies to WEEE categories 1-7 and 10, as stated in the "Article 2 - Scope" section of the directive. As such, Avtech instruments are exempt from the RoHS requirements.

However, Avtech is working towards voluntary compliance, by switching to components which are RoHS-compliant.

WEEE RESPONSIBILITY AGREEMENT
